Dear Ms. Somma:

The Marine Mammal Commission (Commission) has reviewed the National Marine Fisheries Service request for information on the southern right whale (*Eubalaena australis*) for use in the 5-year review of its status under the Endangered Species Act (85 Fed. Reg. 49640). The announcement requested information on this whale species that has become available since the last 5-year review in 2015.

In its response to the 2014 request for information for the previous review, the Commission pointed to several reports generated from International Whaling Commission (IWC) meetings and activities. The IWC Scientific Committee has continued its work with respect to the status of regional populations of southern right whales around the Southern Hemisphere. The Commission again calls attention to the reports of the IWC Scientific Committee's annual meetings (66A (2015), 66B (2016), 67A (2017), 67B (2018), 68A (2019), and 68B (2020)) and their relevant Annexes. These reports, listed in Annex I of this letter with a link to access them, provide updates on research, assessment and management specific to each of the currently recognized southern right whale populations.

The International Union for Conservation of Nature (IUCN) Red List status of the southern right whale was assessed in 2018. While the species as a whole was listed as Least Concern (Cooke & Zerbini 2018), the assessment states that "[S]ome breeding subpopulations are still very small and may need special protection to survive." In 2018, a separate Red List assessment listed the "southern right whale Chile-Peru subpopulation" as Critically Endangered, with fewer than 50 mature individuals (Cooke 2018). The IWC reports referenced above include annual reviews of assessment and management efforts for this regional population, based since 2017 on reports submitted to the Sub-Committee on Cetacean Stocks that are or might be the Subject of Conservation Management Plans (CMPs). For example, SC/68B/CMP/18 "IWC Eastern South Pacific Southern Right Whale Conservation Management Plan – Progress Report April 2020" was submitted to and discussed at the most recent Scientific Committee annual meeting in April 2020.

To further assist in this review the Commission will provide a number of other relevant reports and journal articles along with this letter (Annex II).
