Health, Risk, and Injury Assessments

- Provides technical and financial support for the collection of vital information
 - Diseases
 - Contaminants
 - Hearing
 - Stress
 - Life history
 - **Reproductive success**
 - Anatomy & physiology
 - Distribution
 - Survivorship









National Marine Mammal Tissue Bank

- Provides coordination and financial support for NOAA-NIST partnership
 - 50% of each specimen is available to scientific community for research & scientific evaluations
 - 50% is for long-term storage
 - Researchers may request archived marine mammal tissues for retrospective studies





Unusual Mortality Event Investigation

- Provides administrative and technical support for UME investigation
 - 25 years since massive Atlantic die-offs
 - Since 1991, 59 UMEs declared
 - Most cases involve coastal species
 - Status of UME Contingency Fund
 - Currently six UMEs under investigation

Prescott Grant Program

- Coordinates the review and selection of grant applications and administers awards
- Between 2001-2012:
 - 471 grants awarded to stranding network partners
 - 93 Recipients (25 States+1 DC+2 US Territories)
 - \$43M total amount of awards

 \$41.78M Competitive
 \$1.74M Emergency
 - \$14.4M+ leveraged
